

# 2021 SUMMER PROJECTS RESIDENCY COVID-19 WAIVER OF LIABILITY & INDEMNITY AGREEMENT

UPDATED JUNE 3, 2021



IN CONSIDERATION of using facilities of the Fine Arts Work Center in Provincetown (“FAWC”), including overnight stays at FAWC, the undersigned hereby agrees as follows:

1. I acknowledge the contagious nature of Coronavirus/COVID-19 and that it can lead to severe illness and death.
2. I acknowledge that the CDC and many other public health authorities still recommend wearing a mask and practicing social distancing in certain situations to reduce the spread of COVID-19.
3. I acknowledge that FAWC requires that I social distance and wear a mask in certain situations, and follow certain other practices and protocols while in residence at FAWC, all as set forth in the attached Policies document.
4. I am not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
5. I do not believe I have been exposed to someone with a suspected and/or confirmed case of COVID-19.
6. I have not been diagnosed with COVID-19 and not yet cleared as non-contagious by state or local public health authorities.
7. I will notify FAWC of any changes, specifically regarding line items #4 - #6, related to COVID-19 from the period this document is dated and signed to my arrival at FAWC.
8. I understand that FAWC reserves the right to dismiss Artists that do not follow COVID procedures after being verbally warned, and require their immediate departure from the residency program, at any time, without financial compensation.

I hereby voluntarily assume all risks related to exposure to COVID-19 at FAWC and agree to indemnify and hold FAWC and its trustees, officers, employees, volunteers and agents harmless regarding any and all causes of action, claims, demands, damages, costs, expenses and compensation arising from any COVID-19 infections that are in any way connected to my stay at FAWC or participation in any FAWC program or event.
